Hilton, Stephens, McGinnis eyeing 2 city council seats

The Nov. 3 election will feature three candidates running for two seats on the Oakwood City Council. Mayor Judy Cook has announced she will be stepping down from her post this year after 20 years on the council and her last two terms (eight years) as mayor. "I felt it was about time for someone else to have the job," Cook said. The other seat is up for grabs as incumbent Vice Mayor Carlo McGinnis will be seeking his seventh term and 25th year on the Oakwood City Council. Two new candidates have also filed for seats on the Oakwood City Council and will be on the ballot Nov. 3. Lifelong residents Anne Shank Hilton and Rob Stephens will also be campaigning for votes on the Nov. 3 ballot. Following is a comprehensive resume of the three candidates:

School board candidates election uncontested

Next issue (Oct. 27) will be a candidate run-down for Oakwood School Board candidates Chris Epley, Mike Miller and incumbent Elizabeth Rieger. Board members Beth Merritt and Dr. Paul Vanderburgh have chosen to resign their seats this next term. They will continue to serve on the board until the end of December. The school board election will be uncontested as there are three seats

and three candidates seeking the post.

Another added twist to the school board election is that board member Debra Hershey has recently resigned and 14 citizens have sent in their resumes seeking the seat. The board will be interviewing candidates Thursday and Friday and plan to take formal action on selecting one candidate for the post on Monday, Oct. 26.
